vs.

TULSA PIER, INC.

ORDER

The Board voted unanimously that Tulsa Pier, Inc. shall pay a civil penalty of \$941.00 for violation of Act 150; \$941.00 for violation of Act 162 as amended for a total of \$1,882.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Joseph Thompson shall pay a civil penalty of \$970.00 for violation of Act 150; \$970.00 for violation of Act 162 as amended for a total of \$1,940.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Premier Cabinet Co., LLC shall pay a civil penalty of \$647.00 for violation of Act 150; \$647.00 for violation of Act 162 as amended for a total of \$1,294.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ROB MILLER, D/B/A MILLER EXCAVATING

ORDER

The Board voted unanimously that Rob Miller, d/b/a Miller Excavating shall pay a civil penalty of \$1,474.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

vs.

GNM CONSTRUCTION, INC

ORDER

The Board voted unanimously that GNM Construction, Inc shall pay a civil penalty of \$3,425.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order. Further the Board will not review any renewal or new application for this company for a period of six (6) months. GNM Construction, Inc. shall refrain from bidding on or performing work on any

projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

ORDER

The Board voted unanimously that Matt Duke shall pay a civil penalty of \$1,770.00 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
