ARKANSAS CONTRACTORS LICENSING BOARD

vs.

GARY ROBERTSON, D/B/A GARY ROBERTSON PLUMBING

ORDER

The Board voted unanimously that Gary Robertson, d/b/a Gary Robertson Plumbing shall pay a civil penalty of \$1,350.00 for violation of Act 150; \$1,350.00 for violation of Act 162 as amended for a total of \$2,700.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

COLONEL CRAGO, D/B/A ALL ABOUT ROOFING

ORDER

The Board voted unanimously that Colonel Crago, d/b/a All About Roofing shall pay a civil penalty of \$11,134.00 for violation of Act 150; \$11,134.00 for violation of Act 162 as amended for a total of \$22,268.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ALLEN'S STEEL PRODUCTS, INC.

ORDER

The Board voted unanimously that Allen's Steel Products, Inc. shall pay a civil penalty of \$1,860.00 for violation of Act 150; \$6,200.00 for violation of Act 162. Will issue license when penalty paid as amended for a total of \$8,060.00 to the Board, payable within twenty (20) days of receipt of this Order. Further the Board ordered that the license of Allen's Steel Products of Arkansas, LLC not be released until such time as this penalty is paid in full. Allen Steel Products, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Laferrriere Holdings, Inc., d/b/a Father & Sons Construction shall pay a civil penalty of \$2,790.00 for violation of Act 150; \$2,790.00 for violation of Act 162 as amended for a total of \$5,580.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

Code Ann. § 17-25-401, *et seq.*

ORDER

The Board voted unanimously that Fernando Aguirre shall pay a civil penalty of \$778.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
