FINDINGS OF FACT

ARKANSAS CONTRACTORS LICENSING BOARD

VS

TORRE CARTER, D/B/A CARTER PAINTING & COATING

The Board voted unanimously that Torre Carter, d/b/a Carter Painting & Coating shall pay a civil penalty of \$990.00 for violation of Act 150; \$990.00 for violation of Act 162 as amended for a total of \$1,980.00 to the Board, payable within twenty (20) days of receipt of this Order. This amount shall be reduced by one-half if he obtains an Arkansas Contractors License within 1 year of the date of the hearing. Torre Carter, d/b/a Carter Painting & Coating shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

JOHN MIZELL, D/B/A MIZELL HEATING & AIR CONDITIONING

The Board voted unanimously that John Mizell, d/b/a Mizell Heating & Air Conditioning shall pay a civil penalty of \$906.00 for violation of Act 150; \$906.00 for violation of Act 162 on the Papa Joes project and \$1,762.00 for violation of Act 150; \$3,524.00 for violation of Act 162 on the David's Bridal project as amended for a total of \$6,098.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

MBK CONSTRUCTION CORP.

The Board voted unanimously that MBK Construction Corp. shall pay a civil penalty of \$6,000.00 for violation of Act 150; \$6,000.00 for violation of Act 162 as amended for a total of \$12,000.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

MILES MANUFACTURING, INC.

The Board voted unanimously that Miles Manufacturing, Inc. shall pay a civil penalty of \$1,211.00 for violation of Act 150; \$1,211.00 for violation of Act 162 as amended for a total of \$2,422.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.
