ARKANSAS CONTRACTORS LICENSING BOARD

vs.

A.J. HUEY, D/B/A SOLID ROCK BUILDERS

ORDER

The Board voted unanimously that A.J. Huey, d/b/a Solid Rock Builders shall pay a civil penalty of \$3,765.00 for violation of Act 150; \$3,765.00 for violation of Act 162 as amended for a total of \$7,530.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

HOWELL UTILITY AND EXCAVATION, INC

The Board voted unanimously that the license of Howell Utility and Excavation, Inc is suspended for misconduct until such time as Howell Utility and Excavation, Inc. appear before the Board to discuss this matter. Howell Utility and Excavation, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

BOMASADA INVESTMENT GROUP II L.L.C.

The Board voted unanimously that Bomasada Investment Group II L.L.C. shall pay a civil penalty of \$38,563.00 for using unlicensed subcontractors and

revoked the license of Bomasada Investment Group, II L.L.C. for aiding or abetting unlicensed contractors to the Board. This amount is payable within twenty (20) days of receipt of this Order and Bomasada Investment Group II L.L.C. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

CHRIS SMITH, D/B/A BIG SMITH ROOFING

The Board voted unanimously that Chris Smith, d/b/a Big Smith Roofing shall pay a civil penalty of \$1,872.00 for violation of Act 150; \$1,872.00 for violation of Act 162 as amended for a total of \$3,744.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
