FINDINGS OF FACT**

**ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**vs.**

**TOMMY WALLIS, D/B/A OZARK CEDAR SPECIALTIES**

**ORDER**

The Committee voted unanimously that Tommy Wallis, d/b/a Ozark Cedar Specialties shall pay a civil penalty of \$6,434.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**vs.**

**CRAM CUSTOM HOMES, INC.**

**ORDER**

The Committee voted unanimously that the license of Cram Custom Homes, Inc. is hereby revoked for misconduct for violation of Act 950. Cram Custom Homes, Inc. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**JOHNNY KING CONSTRUCTION CO.**

**ORDER**

The Committee voted unanimously that the license of Johnny King Construction Co. is suspended for violation of Act 950 until such time as the complaint filed against them is satisfied. Johnny King Construction Co. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**PRICHARD HOMES, LLC**

**ORDER**

The Committee voted unanimously that the license of Prichard Homes, LLC is hereby revoked for violation of Act 950. Prichard Homes, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**ORDER**

The Committee voted unanimously that James E. Lee, d/b/a Lee Construction Company shall pay a civil penalty of \$6,270.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**EDWARD SPIVEY, D/B/A LAKESIDE CABINS & CARPORTS INC**

**ORDER**

The Committee voted unanimously that Edward Spivey, d/b/a Lakeside Cabins & Carports Inc shall pay a civil penalty of \$13,424.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. Further, the Committee ordered a cease and desist order be issued against Edward Spivey, d/b/a Lakeside Cabins & Carports, Inc. for any work that would require him to have an Arkansas Residential Contractors License.

**VICKI BRONSON**

**ORDER**

The Committee voted unanimously that Vicki Bronson shall pay a civil penalty of \$3,500.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**MADISON DEVELOPMENT PROPERTIES, INC.**

**ORDER**

The Committee voted unanimously that the license of Madison Development Properties, Inc. is hereby revoked for violation of Act 950. Madison Development Properties, Inc. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**ORDER**

The Committee voted unanimously that the license of Menard Construction, Inc. is hereby revoked for violation of Act 950. Menard Construction, Inc. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
