ARKANSAS CONTRACTORS LICENSING BOARD

VS

RK GENERAL CONTRACTING, LLC

ORDER

The Board voted unanimously that the license of RK General Contracting, LLC is hereby revoked for misconduct. RK General Contracting, LLC shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board. Further, the Board voted unanimously to authorize a cease and desist order for any work that RK General Contracting, LLC performs in violation.

CACCO INTERIOR FINISH CARPENTRY, LLC

ORDER

The Board voted unanimously that CACCO Interior Finish Carpentry, LLC shall pay a civil penalty of \$7,096.00 for violation of Act 150; \$7,096.00 for violation of Act 162 as amended for a total of \$13,392.00 after a previous payment made by CACCO Interior Finish Carpentry, LLC is applied to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

FREEDOM AIR CONDITIONING, L.P.

ORDER

The Board voted unanimously that Freedom Air Conditioning, L.P. shall pay a civil penalty of \$45,759.00 for violation of Act 150; \$152,530.00 for violation of Act 162 as amended for a total of \$198,298.00 to the Board, payable within

twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

NOAH LOYD, D/B/A SUPERIOR METAL COMPANIES, LLC AND SUPERIOR METAL, INC.

ORDER

The Board voted unanimously that Noah Loyd, d/b/a Superior Metal Companies, LLC and Superior Metal, Inc. shall pay a civil penalty of \$400.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board. Further the Board voted to authorize a cease and desist order on any work that Noah Loyd, d/b/a Superior Metal Companies, LLC and Superior Metal, Inc. performs in violation.
