ARKANSAS CONTRACTORS LICENSING BOARD

ORDER

The Board voted unanimously that Roy Lee Jones, Jr., d/b/a Roy Lee Jones, Jr. Construction Co. shall pay a civil penalty of \$1,890.00 for violation of Act 150; \$1,890.00 for violation of Act 162. This amount shall be reduced by 1/2 if Roy Lee Jones, Jr., d/b/a Roy Lee Jones, Jr. Construction Co. is licensed within 120 days as amended for a total of \$\$1,890.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Kerry Turner, d/b/a Turner Construction shall pay a civil penalty of \$2,123.00 for violation of Act 150; \$2,123.00 for violation of Act 162 as amended for a total of \$4,246.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
