ORDER

The Board voted unanimously that Ernesi Garcia, d/b/a Garcia Heat & Air shall pay a civil penalty of \$913.00 for violation of Act 150; \$913.00 for violation of Act 162 as amended for a total of \$1,826.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

RODOLFO TELLEZ

ORDER

The Board voted unanimously that Rodolfo Tellez shall pay a civil penalty of \$1,015.00 for violation of Act 150; \$1,015.00 for violation of Act 162 as amended for a total of \$2,030.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

JUAN PEREZ, D/B/A JUAN PEREZ CONCRETE

ORDER

The Board voted unanimously that Juan Perez, d/b/a Juan Perez Concrete shall pay a civil penalty of \$1,201.00 for violation of Act 150; \$2,002.00 for violation of Act 162 as amended for a total of \$3,203.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

ARCHITECTURAL MATERIALS CO.

ORDER

The Board voted unanimously that Architectural Materials Co. shall pay a civil penalty of \$1,021.00 for violation of Act 150; \$3,406.00 for violation of Act 162 as amended for a total of \$4,427.00 to the Board, payable within twenty (20) days of receipt of this Order. Further the Board issued a cease and desist order on any work that Architectural Material Co. performs that is in excess of \$20,000.00. Architectural Materials Co., shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
