### **ORDER**

The Committee voted unanimously that MARTIN CARDER, LLC, d/b/a PERKINS PREFERRED ROOFING & CONSTRUCTION shall pay a civil penalty of \$400.00 per day for 22 days of activity for a total of \$8,800.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

SHANE HENSON shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

The Committee further ordered that a cease and desist order be issued against JOE MARTIN, d/b/a WATER WORKS, AKA HOOSIER POOL MAN to prevent him from performing work in violation. JOE MARTIN, d/b/a WATER WORKS, AKA HOOSIER POOL MAN shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
