ORDER

The Board voted unanimously that Ronald Parker Holmes, d/b/a Architectural Glass shall pay a civil penalty of \$1,004.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

The Board voted unanimously that Steve Sterns, d/b/a Blooming Arbors Landscaping shall pay a civil penalty of \$2,154.00 for violation of Act 150; \$2,154.00 for violation of Act 162 as amended for a total of \$3,858.00 after previous payments are applied to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

Code Ann. § 17-25-401, *et seq.*
