FINDINGS OF FACT**

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

MICKEAL D. WHITE, D/B/A GMJ CONSTRUCTION COMPANY

ORDER

The Committee voted unanimously that Mickeal D. White, d/b/a GMJ Construction Company shall pay a civil penalty of \$898.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

DAVID KATRANA, D/B/A A M CONSTRUCTION

ORDER

The Committee voted unanimously that David Katrana, d/b/a A M Construction shall pay a civil penalty of \$3,840.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

vs.

QUALITY WOODWORKS, INC.

ORDER

The Committee voted unanimously that the license of Quality Woodworks, Inc. is hereby revoked. Quality Woodworks, Inc. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

AL'SHER INC.

ORDER

The Committee voted unanimously that the license of Al'Sher Inc. is hereby revoked. Al'Sher, Inc. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

J.H.B. INVESTMENTS, LLC

ORDER

The Committee voted unanimously that the license of J.H.B. Investments, LLC is hereby revoked. J.H.B. Investments, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

VERLON WALLER

ORDER

The Committee voted unanimously that Verlon Waller shall pay a civil penalty of \$5,340.00 reduced to \$1,780.00 on the condition that there are no further violations for 2 years and that payment of the \$1,780.00 is timely made for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
