ARKANSAS CONTRACTORS LICENSING BOARD

vs.

RICHARD RYDER

ORDER

The Board voted unanimously that Richard Ryder shall pay a civil penalty of \$1,802.00 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

THE STORE KRAFT MANUFACTURING COMPANY

ORDER

The Board voted unanimously that The Store Kraft Manufacturing Company shall pay a civil penalty of \$6,000.00 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

ADKINS CONSTRUCTION SERVICES, INC.

ORDER

The Board voted 5 to 1 that the license of Adkins Construction Services, Inc. is hereby revoked. Adkins Construction Services, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

vs.

DIEGO CARDONA, D/B/A RODRIGUEZ MASONRY

ORDER

The Board voted unanimously that Diego Cardona, d/b/a Rodriguez Masonry shall pay a civil penalty of \$1,470.00 for violation of Act 150; \$2,450.00 for violation of Act 162 as amended for a total of \$3,920.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

TOMMY M. SIMMONS, D/B/A ARKANSAS MAINTENANCE

ORDER

The Board voted unanimously that Tommy M. Simmons, d/b/a Arkansas Maintenance shall pay a civil penalty of \$808.00 for violation of Act 150; \$808.00 for violation of Act 162 as amended for a total of \$1,616.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
