ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

HEARTWOOD LOG HOMES, INC.

ORDER

The Committee voted unanimously that the license of Heartwood Log Homes, Inc. is suspended for two years. Heartwood Log Homes, Inc. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
