**ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**vs.**

**KEN MCCOY, D/B/A KEN MCCOY, GENERAL CONTRACTOR**

**ORDER**

The Committee voted unanimously that Ken McCoy, d/b/a Ken McCoy, General Contractor shall pay a civil penalty of \$3,410.00 for violation of Act 950 payable to the Committee within five (5) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**S.A.C. WIRELINE, INC.**

**ORDER**

The Committee voted 4 to 2 that S.A.C. Wireline, Inc. shall pay a civil penalty of \$1,660.00 suspended if no further violations within 2 years for violation of Act 950 and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**ORDER**

The Committee voted 4 to 2 that Cris Salazar shall pay a civil penalty of \$3,600.00 for violation of Act 950 payable to the Committee within five (5) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
