ARKANSAS CONTRACTORS LICENSING BOARD

vs.

CARMICHAEL BUILT, INC.

ORDER

The Board voted unanimously that Carmichael Built, Inc. shall pay a civil penalty of \$1,935.75 for violation of Act 150; \$1,935.75 for violation of Act 162 as amended for a total of \$3,871.50 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

GARY BASEY, D/B/A BASEY'S ROOFING

ORDER

The Board voted unanimously that Gary Basey, d/b/a Basey's Roofing shall pay a civil penalty of \$400.00 for bidding without a license on the apartment project in Springdale, Arkansas; \$1,405.20 for violation of Act 150 and \$1,405.20 for violation of Act 162 as amended for the project in Bella Vista, Arkansas for a total of \$3,210.40 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ORDER

The Board voted 3 to 2 that Misael V. Villatoro shall pay a civil penalty of \$500.00 for violation of Act 150 and Act 162 as amended for a total of \$500.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

HARRIS MANUFACTURING, INC., D/B/A HARRIS LIGHTING

ORDER

The Board voted unanimously that Harris Manufacturing, Inc., d/b/a Harris Lighting shall pay a civil penalty of \$2,872.98 for violation of Act 150; \$2,872.98 for violation of Act 162 as amended for a total of \$5,745.96 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

JIMMY DISMUKE, D/B/A C & D CONTRACTORS

ORDER

The Board voted unanimously that Jimmy Dismuke, d/b/a C & D Contractors shall pay a civil penalty of \$400.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

ARNDT ENTERPRISES, INC.

ORDER

The Board voted unanimously that Arndt Enterprises, Inc. shall pay a civil penalty of \$400.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

CESAR ISLAS

ORDER

The Board voted unanimously that Cesar Islas shall pay a civil penalty of \$623.85 for violation of Act 150 reduced by half if licensed within 120 days to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
