vs.

JAY PRESLEY, D/B/A JCS INTERIORS

ORDER

The Board voted unanimously that Jay Presley, d/b/a JCS Interiors shall pay a civil penalty of \$3,180.00 for violation of Act 150; \$3,180.00 for violation of Act 162 as amended for a total of \$6,360.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ORDER

The Board voted unanimously that Prime Communications, LLC shall pay a civil penalty of \$2,370.00 for Act 150; \$7,902.00 for violation of Act 162 as amended for a total of \$10,272.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Gerald Starr & Jerry Kelley, d/b/a G & J Contractors shall pay a civil penalty of \$5,960.00 for violation of Act 150; \$5,960.00 for violation of Act 162 as amended for a total of \$11,920.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

vs.

WORLDWIDE FLOOR, INC.

ORDER

The Board voted unanimously that Worldwide Floor, Inc. shall pay a civil penalty on Country Inn project of \$2,000.00 reduced to \$1,000.00 for violation of Act 150; \$2,000.00 reduced to \$1,000.00 for violation of Act 162; and for the Homewood Suites project a civil penalty of \$7,144.00 reduced to \$2,381.00 for violation of Act 150; \$7,144.00 reduced to \$2,381.00 for Act 162 as amended for a total penalty of \$18,288.00 to be reduced to \$6,762.00 if there are no further violations within 3 years to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ENGLEWOOD CONSTRUCTION, INC.

ORDER

The Board voted unanimously that Englewood Construction, Inc. shall pay a civil penalty of \$13,772.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing

work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
