ARKANSAS CONTRACTORS LICENSING BOARD

VS

RC INC., D/B/A RC INC. OF ARKANSAS

ORDER

The Board voted unanimously that the license of RC Inc., d/b/a RC Inc. of Arkansas is hereby revoked for misconduct. Further the Board voted that a cease and desist order shall be issued in the event that R C Inc., d/b/a RC Inc. of Arkansas does any future work in violation of the Contractors Licensing Law. R C Inc., d/b/a R C Inc. of Arkansas shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

EROSION CONTROL SPECIALIST, INC.

The Board voted unanimously that the license of Erosion Control Specialist, Inc. is hereby revoked for misconduct however, Erosion Control Specialist, Inc. is not prohibited from completing any work that is currently under contract. Erosion Control Specialist, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
