ARKANSAS CONTRACTORS LICENSING BOARD

vs.

FALCON MECHANICAL CONTRACTORS, INC.

ORDER

The Board voted 5 to 1 that Falcon Mechanical Contractors, Inc. shall pay a civil penalty of \$5,000.00 for working out of class and fraud or deceit in obtaining a license to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

ORDER

The Board voted unanimously that Rodney Needham shall pay a civil penalty of \$2,599.00 for violation of Act 150; \$2,599.00 for violation of Act 162 as amended for a total of \$5,198.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

The Board voted unanimously that Clemon Whiteside shall pay a civil penalty of \$864.00 for violation of Act 150; \$864.00 for violation of Act 162 as amended for a total of \$1,728.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted 3 to 2 that John McNeill, d/b/a McNeill Electric shall pay a civil penalty of \$1,023.00 for violation of Act 150; \$1,023.00 for violation of Act 162 as amended for a total of \$2,046.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

Code Ann. § 17-25-401, *et seq.*
