FINDINGS OF FACT

ARKANSAS CONTRACTORS LICENSING BOARD

VS

EDWARD SPIVEY, D/B/A LAKESIDE CABINS & CARPORTS INC

ORDER

The Board voted unanimously that Edward Spivey, d/b/a Lakeside Cabins & Carports Inc shall pay a civil penalty of \$1,350.00 for violation of Act 150; \$2,250.00 for violation of Act 162 as amended for a total of \$4,950.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further issued a cease and desist order on any work until Edward Spivey, d/b/a Lakeside Cabins & Carports Inc. appears before the Board. Edward Spivey, d/b/a Lakeside Cabins & Carports Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Car Wash Products and Service Inc shall pay a civil penalty of \$8,558.00 for violation of Act 150; \$8,558.00 for violation of Act 162 as amended for a total of \$17,116.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Gerardo Hernandez, d/b/a Pearl Construction shall pay a civil penalty of \$1,050.00 for violation of Act 150; \$1,050.00 for violation of Act 162 as amended for a total of \$2,100.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Gerardo Robles, d/b/a Robles Interiors shall pay a civil penalty of \$3,150.00 for violation of Act 150; \$3,150.00 for violation of Act 162 as amended for a total of \$6,300.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
