

## **JANUARY 24, 2024 HEARINGS**

### **ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**vs**

### **DANA TURNAGE, D/B/A RAIN PROOF ROOFING AND RESTORATION**

#### **ORDER**

The Committee voted unanimously that DANA TURNAGE, d/b/a RAIN PROOF ROOFING AND RESTORATION shall pay a civil penalty of \$400 per day for 2 days of activity for a total of \$800 for working without a license. The Committee further ordered that the contractor's license and registration is revoked for misconduct. This revocation is suspended for 90 days to give the contractor time to pay homeowner, the previous judgment, and this penalty. DANA TURNAGE, d/b/a RAIN PROOF ROOFING AND RESTORATION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

### **KENDALL PEARCE, D/B/A KP SERVICES**

#### **ORDER**

The Committee voted unanimously that KENDALL PEARCE, d/b/a KP SERVICES shall pay a civil penalty of \$400 per day for 138 days of activity for a total of \$55,200 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against KENDALL PEARCE, d/b/a KP SERVICES to prevent them from performing work in violation. KENDALL PEARCE, d/b/a KP SERVICES shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

IOAN CIMUCA, d/b/a EUROPEAN DESIGNER shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. The Committee voted unanimously that NARCISO MENDEZ, d/b/a MENDEZ CONSTRUCTION & REMODELING shall pay a civil penalty of \$400 per day for 6 days for a total of \$2,400 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against NARCISO MENDEZ, d/b/a MENDEZ CONSTRUCTION & REMODELING to prevent them from performing work in violation. NARCISO MENDEZ, d/b/a MENDEZ CONSTRUCTION & REMODELING shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

SUNERGY SOLAR LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.
