

## **MARCH 15, 2023 HEARINGS**

### **ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**vs**

### **JOSHUA LYNCH, D/B/A LYNCH CONSTRUCTION**

#### **ORDER**

The Committee voted unanimously that the license of JOSHUA LYNCH, d/b/a LYNCH CONSTRUCTION is revoked for misconduct. JOSHUA LYNCH, d/b/a LYNCH CONSTRUCTION shall pay a civil penalty of \$400 per day for 77 days of activity for a total of \$30,800 for violation of Section 17-25-507(b), performing work not within the classification held by the contractor. This penalty is payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against JOSHUA LYNCH, d/b/a LYNCH CONSTRUCTION to prevent them from performing work in violation. JOSHUA LYNCH, d/b/a LYNCH CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

### **JOSHUA HUFFMAN, D/B/A ALL THINGS NEW DETAILING & HOME RENOVATIONS**

#### **ORDER**

The Committee voted unanimously that JOSHUA HUFFMAN, d/b/a ALL THINGS NEW DETAILING & HOME RENOVATIONS shall pay a civil penalty of \$400 per day for 30 days of activity for a total of \$12,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against JOSHUA HUFFMAN, d/b/a ALL THINGS NEW DETAILING & HOME RENOVATIONS to prevent them from performing work in violation. JOSHUA HUFFMAN, d/b/a ALL THINGS NEW DETAILING & HOME RENOVATIONS shall refrain from bidding on or performing work as a residential

contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

The Committee voted unanimously that BLAKE ARNOLD, d/b/a ALL TRADES HOME REPAIR shall pay a civil penalty of \$400 per day for 100 days of activity for a total of \$40,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against BLAKE ARNOLD, d/b/a ALL TRADES HOME REPAIR to prevent them from performing work in violation. BLAKE ARNOLD, d/b/a ALL TRADES HOME REPAIR shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

The Committee further ordered that a cease and desist order be issued against TERRY HAMMETT, d/b/a BOBBITT CONSTRUCTION to prevent them from performing work in violation. TERRY HAMMETT, d/b/a BOBBITT CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. ### **ORDER**

The Committee voted unanimously that the license of ANGELO BROCATO, d/b/a ANGELO BROCATO'S PAINTING & MAINTENANCE is revoked for misconduct and ANGELO BROCATO, d/b/a ANGELO BROCATO'S PAINTING & MAINTENANCE shall pay a civil penalty of \$400 per day for 80 days of activity for a total of \$32,000 for violation of Section 17-25-507(b) for performing work not within the classification held by the contractor. The penalty is payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against ANGELO BROCATO, d/b/a ANGELO BROCATO'S PAINTING & MAINTENANCE to prevent them from performing work in violation. ANGELO BROCATO, d/b/a ANGELO BROCATO'S PAINTING & MAINTENANCE shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.
