

## **MARCH 16, 2022 HEARINGS**

### **ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**vs**

### **ROOF CONSULTANTS OF ARKANSAS INC, D/B/A LITTLE ROCK HOME SOLUTIONS AND ROOFING**

#### **ORDER**

The Committee voted unanimously that the license of ROOF CONSULTANTS OF ARKANSAS INC, d/b/a LITTLE ROCK HOME SOLUTIONS AND ROOFING is revoked for misconduct but chose to leave their roofing registration in place. The Committee further ordered the roofing registration to expire on September 30, 2022. The Committee further allowed the contractor 6 months to resolve all lawsuits. ROOF CONSULTANTS OF ARKANSAS INC, d/b/a LITTLE ROCK HOME SOLUTIONS AND ROOFING shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

### **DEWAYNE BOSWELL, D/B/A UC LAWNS; ULTIMATE DECKS AND LOGAN POOL CONSTRUCTION, LLC**

#### **ORDER**

The Committee voted unanimously that DEWAYNE BOSWELL, D/B/A UC LAWNS; ULTIMATE DECKS AND LOGAN POOL CONSTRUCTION, LLC shall pay a civil penalty of \$400 per day for 149 days of activity for a total of \$59,600 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. This amount shall be reduced to \$1,000 if contractor reimburses homeowners involved in this case in at least a total amount of \$58,600 on a pro rata basis within 12 months. The Committee further ordered that a cease and desist order be issued against DEWAYNE BOSWELL, D/B/A UC LAWNS; ULTIMATE DECKS AND LOGAN POOL CONSTRUCTION, LLC to prevent them from performing work in violation. DEWAYNE BOSWELL, D/B/A UC LAWNS; ULTIMATE DECKS AND LOGAN POOL CONSTRUCTION, LLC shall refrain

from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**ULTIMATE BUILDERS, LLC AND LOGAN POOL CONSTRUCTION, LLC**

**ORDER**

The Committee voted unanimously that ULTIMATE BUILDERS, LLC AND LOGAN POOL CONSTRUCTION, LLC shall pay a civil penalty of \$400 per day for 344 days of activity for a total of \$137,600 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. This amount shall be reduced to \$5,000 if contractor reimburses homeowners involved in this case in at least a total of \$132,600 on a pro rata basis within 12 months. The Committee further ordered that a cease and desist order be issued against ULTIMATE BUILDERS, LLC AND LOGAN POOL CONSTRUCTION, LLC to prevent them from performing work in violation. ULTIMATE BUILDERS, LLC AND LOGAN POOL CONSTRUCTION, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**AUSTIN LOGAN, D/B/A ULTIMATE POOL CONSTRUCTION**

**ORDER**

The Committee voted unanimously that AUSTIN LOGAN, d/b/a ULTIMATE POOL CONSTRUCTION shall pay a civil penalty of \$400 per day for 143 days of activity for a total of \$57,200 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. This amount shall be reduced to \$1,000 if contractor reimburses homeowners involved in this case in at least a total amount of \$52,200 on a pro rata basis within 12 months. The Committee further ordered that a cease and desist order be issued against AUSTIN LOGAN, d/b/a ULTIMATE POOL CONSTRUCTION to prevent them from performing work in violation. AUSTIN LOGAN, d/b/a ULTIMATE

POOL CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**CRAIG WOOTTON AND DARLA LACKEY, D/B/A FORT SMITH HANDYMAN**

**ORDER**

The Committee voted unanimously that CRAIG WOOTTON AND DARLA LACKEY, d/b/a FORT SMITH HANDYMAN shall pay a civil penalty of \$400 per day for 11 days of activity for a total of \$4,400 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against CRAIG WOOTTON AND DARLA LACKEY, d/b/a FORT SMITH HANDYMAN to prevent them from performing work in violation. CRAIG WOOTTON AND DARLA LACKEY, d/b/a FORT SMITH HANDYMAN shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**JOHN ENGLEMAN**

**ORDER**

The Committee voted unanimously that the license of JOHN ENGLEMAN is revoked for misconduct. JOHN ENGLEMAN shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
