**ORDER**

The Committee voted unanimously that KENNY'S PAINTING AND RENOVATIONS LLC shall pay a civil penalty of \$400 per day for 156 days of activity for working out of class for a total of \$62,400 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee ordered that the license of KENNY'S PAINTING AND RENOVATIONS LLC is revoked for misconduct. The Committee further ordered that a cease and desist order be issued against KENNY'S PAINTING AND RENOVATIONS LLC to prevent them from performing work in violation. This penalty will be reduced to \$5,000 if ABELARDO ALVARADO pays any judgment or settlement with the homeowner within 60 days. ABELARDO ALVARADO shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. The Committee further ordered that a cease and desist order be issued against RICK WARNER, d/b/a RICKS HANDYMAN AND REMODEL SERVICE to prevent them from performing work in violation. RICK WARNER, d/b/a RICKS HANDYMAN AND REMODEL SERVICE shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
