The Board voted unanimously that Jose DeJesus Cardona shall pay a civil penalty of \$1,167.00 for violation of Act 150; \$1,945.00 for violation of Act 162 as amended for a total of \$3,112.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

Code Ann. § 17-25-401, *et seq.*.

ORDER

The Board voted 4 to 1 that Vratsinas Construction Company shall pay a civil penalty of \$26,179.00 reduced to \$13,089.00, provided there are no further violations for 2 years and Vratsinas presents a copy of their Standard Operating Procedures to show how they are dealing with unlicensed subcontractors to the Board, said penalty payable within twenty (20) days of receipt of this Order and refrain from aiding or abetting or using contractors in violation of the contractors licensing law.
