ORDER

The Board voted unanimously that Larry White, d/b/a White & Sons Custom Painting shall pay a civil penalty of \$759.00 for violation of Act 150; \$759.00 for violation of Act 162 as amended for a total of \$1,518.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

RYAN FOSTER, D/B/A R. FOSTER DOZER AND EXCAVATION

ORDER

The Board voted unanimously that Ryan Foster, d/b/a R. Foster Dozer and Excavation shall pay a civil penalty of \$1,440.00 for violation of Act 150; \$1,440.00 for violation of Act 162 as amended for a total of \$2,880.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

vs

AIR ONE SERVICE COMPANY LIMITED LIABILITY COMPANY

ORDER

The Board voted unanimously that Air One Service Company Limited Liability Company shall pay a civil penalty of \$4,550.00 for violation of Act 150; \$7,583.00 for violation of Act 162 as amended for a total of \$12,133.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further ordered that a cease and desist order be issued against Air One Service

Company, Limited Liability Company preventing them from doing any work in violation of the licensing law. Air One Service Company Limited Liability Company shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
