

## MAY 10, 2013 HEARINGS

### ARKANSAS CONTRACTORS LICENSING BOARD

vs

### DIEGO CARDONA, D/B/A CARDONA CONSTRUCTION ORDER

The Board voted unanimously that Diego Cardona, d/b/a Cardona Construction shall pay a civil penalty of \$3,244.00 for violation of Act 150; \$10,814.00 for violation of Act 162 as amended for a total of \$14,058.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further issued a cease and desist order against performing any work in violation. Diego Cardona, d/b/a Cardona Construction shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
