Code Ann. § 17-25-401, *et seq.*

The Board further ordered that a Cease and Desist Order be issued against Robert Lees, d/b/a Mode Corporation/Mode Home, LLC. Robert Lees, d/b/a Mode Corporation/Mode Home, LLC shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
