ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs

DARIN PEGRAM

ORDER

The Committee voted unanimously that the license of DARIN PEGRAM is hereby revoked for misconduct. DARIN PEGRAM shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs

A1 FOAM, LLC

ORDER

The Committee voted unanimously that A1 FOAM, LLC shall pay a civil penalty of \$400.00 per day for 7 days for a total of \$2,800.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against A1 FOAM, LLC to prevent them from performing work in violation. A1 FOAM, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

DAN CURTWRIGHT, D/B/A D C CONSTRUCTION

ORDER

The Committee voted unanimously that DAN CURTWRIGHT, d/b/a D C CONSTRUCTION shall pay a civil penalty of \$400.00 per day for 5 days for a total of \$2,000.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against DAN CURTWRIGHT, d/b/a D C CONSTRUCTION to prevent them from performing work in violation. DAN CURTWRIGHT, d/b/a D C CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

LOUIS BOUNDS, D/B/A BOUNDS ROOFING

ORDER

The Committee voted unanimously that LOUIS BOUNDS, d/b/a BOUNDS ROOFING shall pay a civil penalty of \$400.00 per day for 9 days for a total of \$3,600.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against LOUIS BOUNDS, d/b/a BOUNDS ROOFING to prevent them from performing work in violation. LOUIS BOUNDS, d/b/a BOUNDS ROOFING shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

GRUBCO CONSTRUCTION & DESIGN, LLC

ORDER

The Committee voted unanimously that the license of GRUBCO CONSTRUCTION & DESIGN, LLC is hereby revoked for misconduct. GRUBCO CONSTRUCTION & DESIGN, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

KEEL'S HEATING & AIR LLC

ORDER

The Committee voted unanimously that the license of KEEL'S HEATING & AIR LLC is hereby revoked for providing false evidence to obtain a license and for misconduct for failure to pay a judgment. KEEL'S HEATING & AIR LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

TODD GRISHAM, D/B/A TODD GRISHAM CONSTRUCTION

ORDER

The Committee voted unanimously that TODD GRISHAM, D/B/A TODD GRISHAM CONSTRUCTION shall pay a civil penalty of \$400.00 per day for 6 days for a total of \$2,400.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against TODD GRISHAM, D/B/A TODD GRISHAM CONSTRUCTION to prevent them from performing work in violation. TODD GRISHAM, D/B/A TODD GRISHAM CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
