ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs

JEREMY TERRELL, D/B/A IAT/TRANCEND ROOFING

ORDER

The Committee voted unanimously that JEREMY TERRELL, d/b/a IAT/TRANCEND ROOFING shall pay a civil penalty of \$400.00 for 1 day of activity for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that the previously reduced portion of a settlement agreement entered into by JEREMY TERRELL, d/b/a IAT/TRANCEND ROOFING on September 21, 2016, would not be owed at this time but instead would become due if JEREMY TERRELL, d/b/a IAT/TRANCEND ROOFING had a violation within 3 years of today's date. JEREMY TERRELL, d/b/a IAT/TRANCEND ROOFING shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

vs

JERRY STILES

ORDER

The Committee voted unanimously that JERRY STILES shall pay a civil penalty of \$400.00 per day for 5 days activity for a total of \$2,000.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against JERRY STILES to prevent them from performing work in violation. JERRY STILES shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs

RAYMOND WARREN

ORDER

The Committee voted unanimously that RAYMOND WARREN shall pay a civil penalty of \$400.00 per day for 14 days for a total of \$5,600.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered this amount would be reduced to \$600.00 if RAYMOND WARREN paid the homeowner \$1,500.00 within 90 days and had no further violations for 3 years. Should any judicial action be taken by the homeowner, the 1500.00 is not deemed the total amount of restitution due. RAYMOND WARREN shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

TOMMY KEY

ORDER

The Committee voted unanimously that TOMMY KEY shall pay a civil penalty of \$400 per day for 25 days of activity and cease and desist for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against TOMMY KEY to prevent them from performing work in violation. TOMMY KEY shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

KEITH JOHNSON, D/B/A CHOICE IMPROVEMENTS

ORDER

The Committee voted unanimously that KEITH JOHNSON, d/b/a CHOICE IMPROVEMENTS shall pay a civil penalty of \$400.00 per day for 18 days for a total of \$7,200.00 for violation of Section 17-25-505 payable to the Committee within twenty

(20) days. The Committee further ordered that a cease and desist order be issued against KEITH JOHNSON, d/b/a CHOICE IMPROVEMENTS to prevent them from performing work in violation. KEITH JOHNSON, d/b/a CHOICE IMPROVEMENTS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
