ARKANSAS CONTRACTORS LICENSING BOARD

ORDER

The Board voted unanimously that Sphere Building Services LLC shall pay a civil penalty of \$12,231.00 for violation of Act 150; \$40,709.00 for violation of Act 162 as amended for a total of \$52,940.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further ordered that a cease and desist order be issued against Sphere Building Services, LLC for any work performed in violations. Sphere Building Services, LLC shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that James Norris, d/b/a Heritage Construction shall pay a civil penalty of \$3,462.00 for violation of Act 150; \$3,462.00 for violation of Act 162 as amended for a total of \$6,924.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that All American Barn Builders LLC shall pay a civil penalty of \$5,744.00 for violation of Act 150; \$5,744.00 for violation of

Act 162 as amended for a total of \$11,488.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
