**WILLIAM BROWN, SR., D/B/A BROWN'S UNITED CONSTRUCTION  
ORDER**

The Committee voted unanimously that the license of WILLIAM BROWN, SR., d/b/a BROWN'S UNITED CONSTRUCTION is hereby revoked for misconduct. The Committee further ordered that a cease and desist order be issued against WILLIAM BROWN, SR., d/b/a BROWN'S UNITED CONSTRUCTION to prevent them from performing work in violation. WILLIAM BROWN, SR., d/b/a BROWN'S UNITED CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ORDER**

The Committee voted unanimously that CHAD GOODWIN, d/b/a GOODWIN CONSTRUCTION shall pay a civil penalty of \$400.00 per day for 38 days for a total of \$15,200.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against CHAD GOODWIN, d/b/a GOODWIN CONSTRUCTION to prevent them from performing work in violation. CHAD GOODWIN, d/b/a GOODWIN CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

The Committee further ordered that a cease and desist order be issued against WARNERS REMODELING & CONSTRUCTION, LLC to prevent them from performing work in violation. WARNERS REMODELING & CONSTRUCTION, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
