ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

VS

VERNON WILKINS, D/B/A WILKINS AND BRAGG CONSTRUCTION

ORDER

The Committee voted unanimously that Vernon Wilkins, d/b/a Wilkins and Bragg Construction shall pay a civil penalty of \$400.00 per day for 7 days for a total of \$2,600.00, after previous payments made by that Vernon Wilkins, d/b/a Wilkins and Bragg Construction are applied, for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee voted to reduce the penalty owed to \$200.00 if paid within 30 days. Vernon Wilkins, d/b/a Wilkins and Bragg Construction shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS LAND AND EQUIPMENT, LLC

ORDER

The Committee voted unanimously that Arkansas Land and Equipment, LLC shall pay a civil penalty of \$400.00 per day for 730 days for a total of \$292,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against Arkansas Land and Equipment, LLC to prevent them from performing work in violation and that information regarding this case be turned over to the prosecuting attorneys in Garland and Saline Counties, the Arkansas Real Estate Commission, and the Arkansas Attorney General. Arkansas Land and Equipment, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
