#### **ORDER**

The Committee voted unanimously that the license of GREG PECTOL, d/b/a PRIMETIME ENTERPRISE is hereby revoked for misconduct. GREG PECTOL, d/b/a PRIMETIME ENTERPRISE shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

HOME REPAIR to prevent him from performing work in violation. CARLTON ROBINSON, d/b/a COMPLETE HOME REPAIR shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
