### **ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**vs**

**JOSEPH O'NEILL, D/B/A JNH REMODELING AND JOSEPH AND HOLLY  
REMODELING AND JNS REMODELING AND JOSEPH AND SHELBY  
REMODELING**

#### **ORDER**

The Committee voted unanimously that JOSEPH O'NEILL, d/b/a JNH REMODELING AND JOSEPH AND HOLLY REMODELING AND JNS REMODELING AND JOSEPH AND SHELBY REMODELING shall pay a civil penalty of \$400 per for day for 14 days of activity for a total of \$5,600 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. JOSEPH O'NEILL is solely responsible for this debt. The Committee voted unanimously that HOLLY O'NEILL should receive only a written warning for her involvement in this matter. The Committee found no evidence that Shelby was involved in this matter. The Committee further ordered that a cease and desist order be issued against JOSEPH O'NEILL, d/b/a JNH REMODELING AND JOSEPH AND HOLLY REMODELING AND JNS REMODELING AND JOSEPH AND SHELBY REMODELING to prevent them from performing work in violation. ROB MCNUTT & ZINA MCNUTT, d/b/a RUSTIC REMODELING shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

RANDY CLARK, d/b/a RANDY CLARK CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
