ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs

JEREMY RUPERT

ORDER

The Committee voted unanimously that JEREMY RUPERT shall pay a civil penalty of \$400.00 per day for 1 day of activity for a total of \$400.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against JEREMY RUPERT to prevent them from performing work in violation. JEREMY RUPERT shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

DIAMOND STATE DESIGNS LLC

ORDER

The Committee voted unanimously that DIAMOND STATE DESIGNS LLC shall pay a civil penalty of \$400.00 per day for 15 days of activity for a total of \$6,000.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against DIAMOND STATE DESIGNS LLC to prevent them from performing work in violation. DIAMOND STATE DESIGNS LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

JOE MARTIN, D/B/A WATER WORKS

ORDER

The Committee voted unanimously that JOE MARTIN, d/b/a WATER WORKS shall pay a civil penalty of \$400.00 per day for 15 days of activity for a total of \$6,000.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against JOE MARTIN, d/b/a WATER WORKS to prevent them from performing work in violation. JOE MARTIN, d/b/a WATER WORKS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ANTHONY ROGERS

ORDER

The Committee voted unanimously that ANTHONY ROGERS shall pay a civil penalty of \$400.00 per day for 2 days of activity for a total of \$800.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against ANTHONY ROGERS to prevent them from performing work in violation. ANTHONY ROGERS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

LOUIS BOUNDS, D/B/A BOUNDS ROOFING

ORDER

The Committee voted unanimously that LOUIS BOUNDS, d/b/a BOUNDS ROOFING shall pay a civil penalty of \$400.00 for 1 day and cease and desist for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against LOUIS BOUNDS, d/b/a BOUNDS ROOFING to prevent them from performing work in violation. LOUIS BOUNDS, d/b/a BOUNDS ROOFING shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

LEVI CHASE, D/B/A CHASE HOMES & REMODELING

ORDER

The Committee voted unanimously that LEVI CHASE, d/b/a CHASE HOMES & REMODELING shall pay a civil penalty of \$400.00 per day for 35 days of activity for a total of \$14,000.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against LEVI CHASE, d/b/a CHASE HOMES & REMODELING to prevent them from performing work in violation. LEVI CHASE, d/b/a CHASE HOMES & REMODELING shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
