#### ORDER

The Committee voted unanimously that TODD ROBINSON, d/b/a BRICKMASTER shall pay a civil penalty of \$200.00 per day for 26 days for a total of \$5,600.00 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. This amount shall be reduced to \$1,500.00 if TODD ROBINSON satisfactorily resolves the complaint with Leslie McGhee by either completing the project or repaying the money within 90 days and obtaining a contractors license. TODD ROBINSON, d/b/a BRICKMASTER shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

BRIAN WOOD, d/b/a B-SQUARED CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

However, this amount shall be reduced to \$2,500.00 if STEVE LASLEY, d/b/a LASLEY FARMS obtains a contractors license within 90 days. STEVE LASLEY, d/b/a LASLEY FARMS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
