ARKANSAS CONTRACTORS LICENSING BOARD

ORDER

The Board voted unanimously that Dennis Little, d/b/a Little Construction Firm shall pay a civil penalty of \$975.00 for violation of Act 150; \$1,625.00 for violation of Act 162 as amended for a total of \$2,600.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further ordered that a cease and desist order shall be issued against Dennis Little, d/b/a Little Construction Firm. Dennis Little, d/b/a Little Construction Firm shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
