ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs

ALBERT CARRIZALES, D/B/A ROME ZINN CONSTRUCTION

ORDER

The Committee voted unanimously that ALBERT CARRIZALES, d/b/a ROME ZINN CONSTRUCTION shall pay a civil penalty of \$400.00 per day for 20 days of activity for a total of \$8,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against ALBERT CARRIZALES, d/b/a ROME ZINN CONSTRUCTION to prevent them from performing work in violation. ALBERT CARRIZALES, d/b/a ROME ZINN CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

CASIANO RODRIGUEZ, D/B/A JMR CONTRACTING

ORDER

The Committee voted unanimously that the license of CASIANO RODRIGUEZ, d/b/a JMR CONTRACTING is revoked for misconduct. CASIANO RODRIGUEZ, d/b/a JMR CONTRACTING shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

JUSTIN & MISTY CAMERON, D/B/A ABSOLUTE CONSTRUCTION & REMODELING

ORDER

The Committee voted unanimously that JUSTIN & MISTY CAMERON, d/b/a ABSOLUTE CONSTRUCTION & REMODELING shall pay a civil penalty of \$400.00 per day for 51 days of activity and cease and desist for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against JUSTIN & MISTY CAMERON, d/b/a ABSOLUTE CONSTRUCTION & REMODELING to prevent them from performing work in violation. JUSTIN & MISTY CAMERON, d/b/a ABSOLUTE CONSTRUCTION & REMODELING shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
