ARKANSAS CONTRACTORS LICENSING BOARD

VS

BECKHAM CONTRACTING INC

ORDER

The Board voted unanimously that the license of BECKHAM CONTRACTING INC is revoked for misconduct. BECKHAM CONTRACTING INC shall refrain from bidding on or performing work on any projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board.

VS

BDC REAL ESTATE PARTNERS, LLC

ORDER

The Board voted unanimously that the license of BDC REAL ESTATE PARTNERS, LLC is revoked for misconduct. BDC REAL ESTATE PARTNERS, LLC shall refrain from bidding on or performing work on any projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board.

VS

MINORITY REPORT LLC

ORDER

The Board voted unanimously that the license of MINORITY REPORT LLC is revoked for misconduct. MINORITY REPORT LLC shall refrain from bidding on or performing work on any projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board.

ARKANSAS CONTRACTORS LICENSING BOARD

VS

J&K CONSTRUCTION AND REMODELING LLC

ORDER

The Board voted unanimously that the previous settlement agreement is set aside and that J&K CONSTRUCTION AND REMODELING LLC shall pay a civil penalty of \$1,687 for violation of Act 150; \$1,687 for violation of Act 162 for a total of \$3,374. After credit for a previous payment made by J&K CONSTRUCTION AND REMODELING LLC, the total amount due is \$3,124 payable within twenty (20) days of receipt of this Order. J&K CONSTRUCTION AND REMODELING LLC shall refrain from bidding on or performing work on any projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

VS

RIGHT ANGLE CONSTRUCTION NWA LLC

ORDER

The Board voted unanimously that RIGHT ANGLE CONSTRUCTION NWA LLC shall pay a civil penalty of \$500 for misconduct. The Board further ordered that this matter would be reviewed in 60 days to determine if RIGHT ANGLE CONSTRUCTION NWA LLC was complying with their agreement to pay the homeowner and had paid this penalty. If they are not in compliance, this matter will be renoticed for a hearing to revoke the license of RIGHT ANGLE CONSTRUCTION NWA LLC.
