**ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**VS**

**TODD STEWART, D/B/A STEWART CONSTRUCTION**

### **ORDER**

The Committee voted unanimously that TODD STEWART, d/b/a STEWART CONSTRUCTION shall pay a civil penalty of \$400 per day for 3 days of activity for a total of \$1,200 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against TODD STEWART, d/b/a STEWART CONSTRUCTION to prevent them from performing work in violation. TODD STEWART, d/b/a STEWART CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**CORY BRAY, D/B/A ENVY OUTDOOR KITCHEN CO**

### **ORDER**

The Committee voted unanimously that the license of CORY BRAY, d/b/a ENVY OUTDOOR KITCHEN CO. is suspended until he responds to the complaint and that he be assessed a penalty of \$500 for misconduct. CORY BRAY, d/b/a ENVY OUTDOOR KITCHEN CO. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ULTIMATE POOLS**

**ORDER**

The Committee voted unanimously that AUSTIN LOGAN, d/b/a ULTIMATE BUILDERS/ LOGAN POOL CONSTRUCTION/ ULTIMATE POOLS shall pay a civil penalty of \$400.00 per day for 26 days for a total of \$10,400 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against AUSTIN LOGAN, d/b/a ULTIMATE BUILDERS/ LOGAN POOL CONSTRUCTION/ ULTIMATE POOLS AND ANY OTHER ENTITY THAT AUSTIN LOGAN IS AFFILIATED WITH to prevent them from performing work in violation. AUSTIN LOGAN, d/b/a ULTIMATE BUILDERS/ LOGAN POOL CONSTRUCTION/ ULTIMATE POOLS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**ORDER**

The Committee voted unanimously that ROBERT KNOBBE, d/b/a FLAMINGO HANDYMAN shall pay a civil penalty of \$400 per day for 19 days of activity for a total of \$7,600 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against ROBERT KNOBBE, d/b/a FLAMINGO HANDYMAN to prevent them from performing work in violation. ROBERT KNOBBE, d/b/a FLAMINGO HANDYMAN shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
