FINDINGS OF FACT**

**ARKANSAS CONTRACTORS LICENSING BOARD**

**vs.**

**GREG ALSIP, D/B/A A+ PLUMBING**

**ORDER**

The Board voted unanimously that Greg Alsip, d/b/a A+ Plumbing shall pay a civil penalty of \$844.20 for violation of Act 150 reduced to \$422.10 if licensed within 120 days to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

**ORDER**

The Board voted unanimously that Rodney Holland shall pay a civil penalty of \$500.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

The Board voted unanimously that Wiley Gregory, d/b/a W.G. Construction shall pay a civil penalty of \$1,156.50 for violation of Act 150; \$771.00 for violation of Act 162 as amended for a total of \$1,927.50 to the Board,

payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

Code Ann. § 17-25-401, *et seq.*.

**ORDER**

The Board voted 4 to 1 that Carl Burton, d/b/a Carl's Concrete Service shall pay a civil penalty of \$300.20 for violation of Act 150; \$300.20 for violation of Act 162 as amended for a total of \$600.40 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.
