ARKANSAS CONTRACTORS LICENSING BOARD

vs.

T.D. FARRELL CONSTRUCTION, INC.

ORDER

The Board voted unanimously that T.D. Farrell Construction, Inc. shall pay a civil penalty of \$10,000.00 for using unlicensed subcontractors to the Board payable within five (5) days of receipt of this Order and refrain from aiding or abetting or using contractors in violation of the contractors licensing law.

vs.

FRANKIE SANCHEZ, D/B/A SANCHEZ CONTRACTING

ORDER

The Board voted unanimously that Frankie Sanchez, d/b/a Sanchez Contracting shall pay a civil penalty of \$2,400.00 for violation of Act 150; \$2,400.00 for violation of Act 162 as amended for a total of \$4,800.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

WILSON PAVING & EXCAVATING, INC.

ORDER

The Board voted unanimously with one abstaining that Wilson Paving & Excavating, Inc. shall pay a civil penalty of \$7,836.00 for violation of Act 150; \$7,836.00 for violation of Act 162 as amended for a total of \$15,672.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ESC ROOFING, INC.

ORDER

The Board voted unanimously that ESC Roofing, Inc. shall pay a civil penalty of \$3,876.00 for violation of Act 150; \$2,584.00 for violation of Act 162 as amended for a total of \$6,460.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

PLANETARY UTILITIES, INC.

ORDER

The Board voted unanimously that Planetary Utilities, Inc. shall pay a civil penalty of \$3,060.00 for violation of Act 150; \$2,040.00 for violation of Act 162 as amended for a total of \$5,100.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

JOSEPH STILLMAN, D/B/A JOE STILLMAN CONSTRUCTION

ORDER

The Board voted unanimously that Joseph Stillman, d/b/a Joe Stillman Construction shall pay a civil penalty of \$1,200.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
