**ARKANSAS CONTRACTORS LICENSING BOARD**

**vs.**

**BOB SPRY, d/b/a B.S. METALS**

**ORDER**

The Board voted unanimously that Bob Spry, d/b/a B.S. Metals shall pay a civil penalty of \$1,320.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

**JAMES HARDMAN, d/b/a J & J CONSTRUCTION**

**ORDER**

The Board voted unanimously that James Hardman, d/b/a J & J Construction shall pay a civil penalty of \$15,854.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

The Board voted unanimously that Milton Piper shall pay a civil penalty of \$3,000.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

The Board voted unanimously that Redline Construction, Inc. shall pay a civil penalty of \$1,687.00 for violation of Act 150 and \$1,687.00 for violation of Act 162 for a total of \$3,374.00 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

**PAUL WHITNEY & ASSOCIATES**

**ORDER**

The Board voted unanimously that Paul Whitney & Associates shall pay a civil penalty of \$1,530.00 for violation of Act 150 and \$1,530.00 for violation of Act 162 for a total of \$3,060.00 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

**BP MECHANICAL INSULATION, INC.**

**ORDER**

The Board voted unanimously that BP Mechanical Insulation, Inc. shall pay a civil penalty of \$2,526.00 for violation of Act 150 and \$2,526.00 for violation of Act 162 for a total of \$5,052.00 to the Board payable within five (5) days of receipt of this Order. However, this amount shall be reduced by one-half if BP Mechanical Insulation, Inc. is licensed within 60 days. Further BP Mechanical Insulation, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

**vs.**

**ARKLA CONSTRUCTION, INC.**

**ORDER**

The Board voted unanimously that Arkla Construction, Inc. shall pay a civil penalty of \$687.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order. However, this amount shall be reduced by one-half if Arkla Construction, Inc. is licensed within 60 days. Further Arkla Construction, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
