**ARKANSAS CONTRACTORS LICENSING BOARD**

**vs.**

**HAROLD E. RANDLE, D/B/A RELIABLE COMMERCIAL SERVICES**

**ORDER**

The Board voted unanimously that Harold E. Randle, d/b/a Reliable Commercial Services shall pay a civil penalty of \$2,768.64 for violation of Act 150; \$4,152.96 for violation of Act 162 as amended for a total of \$6,921.60 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

**NRB (USA), INC.**

**ORDER**

The Board voted unanimously that NRB (USA), Inc. shall pay a civil penalty of \$4,000.00 for violation of Act 150; \$12,163.86 for violation of Act 162 as amended for a total of \$16,163.86 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

**CAESARS PAINTING, INC.**

**ORDER**

The Board voted unanimously that Caesars Painting, Inc. shall pay a civil penalty of \$6,840.00 for violation of Act 150; \$6,840.00 for violation of Act 162 as amended for a total of \$13,680.00 to the Board, payable within five (5) days of receipt of this Order. This amount shall be reduced by half if licensed within 120 days. Further, Caesars Painting shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

**ORDER**

The Board voted unanimously that Andy Kirsch, d/b/a Euro-Styl shall pay a civil penalty of \$7,500.00 for violation of Act 150; \$7,500.00 for violation of Act 162 as amended for a total of \$15,000.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

The Board voted unanimously that Central Utility Pipeline Construction Co., Inc. shall pay a civil penalty of \$2,409.87 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

The Board voted unanimously that Milam Excavating & Hauling, Inc. shall pay a civil penalty of \$13,650.30 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
