ARKANSAS CONTRACTORS LICENSING BOARD

vs.

FOREVER GREEN ATHLETIC FIELDS, INC.

ORDER

The Board voted unanimously that Forever Green Athletic Fields, Inc. shall pay a civil penalty of \$2,400.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

vs.

JASON SMITH, D/B/A MULTI-MECHANICAL SERVICE

ORDER

The Board voted unanimously that Jason Smith, d/b/a Multi-Mechanical Service shall pay a civil penalty of \$485.38 for violation of Act 150; \$728.07 for violation of Act 162 as amended for a total of \$1,213.45 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

ORDER

The Board voted unanimously that Don Bennett, d/b/a Don Bennett Remodeling shall pay a civil penalty of \$2,010.00 for violation of Act 150; \$2,010.00 for violation of Act 162 as amended for a total of \$4,020.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

JOHNNY "BO" HENRY

ORDER

The Board voted unanimously that Johnny "Bo" Henry shall pay a civil penalty of \$863.00 for violation of Act 150; \$863.00 for violation of Act 162 as amended for a total of \$1,726.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq..*

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

COENCO, INC.

ORDER

The Board voted unanimously that Coenco, Inc. shall pay a civil penalty of \$1,925.06 for violation of Act 150; and a violation of Act 162 but assessed no penalty as amended for a total of \$1,925.06 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq..*
