

**JUNE 23, 2004 HEARINGS
FINDINGS OF FACT**

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

ERWIN BUSH

ORDER

The Committee voted unanimously that Erwin Bush shall pay a civil penalty of \$2,340.00 for violation of Act 950 payable to the Committee within five (5) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

DARIN W. LIVELY, D/B/A OUT WEST CONSTRUCTION

ORDER

The Committee voted unanimously that Darin W. Lively, d/b/a Out West Construction shall pay a civil penalty of \$2,790.00 for violation of Act 950 payable to the Committee within five (5) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

WILSON SISCO, LLC

ORDER

The Committee voted unanimously that Wilson Sisco, LLC shall pay a civil penalty of \$275.00 for violation of Act 950 payable to the Committee within five (5) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

DEEP STREAM, LLC

ORDER

The Committee voted 5 to 1 that Deep Stream, LLC shall pay a civil penalty of \$59,169.75 reduced to \$29,584.87 if licensed within 60 days and no further violations for 2 years for violation of Act 950 payable to the Committee within five (5) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

J & H PAINTING AND CARPENTRY, INC.

ORDER

The Committee voted 5 to 1 that J & H Painting and Carpentry, Inc. shall have its Residential License suspended for 1 year for violation of Act 950.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

BETTER HOMES OF ARKANSAS CONSTRUCTION, LLC

ORDER

The Committee voted unanimously that Better Homes of Arkansas Construction, LLC shall pay a civil penalty of \$2,774.80 suspended if licensed within 60 days for violation of Act 950 payable to the Committee within five (5) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

RALPH L. HARPER

ORDER

The Committee voted unanimously that Ralph L. Harper shall pay a civil penalty of \$5,055.51 for violation of Act 950 payable to the Committee within five (5) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
