**ORDER**

The Board voted unanimously that Louis Mitchell, d/b/a Louis Mitchell Building Contractor shall pay a civil penalty of \$624.00 for violation of Act 150; \$624.00 for violation of Act 162 as amended for a total of \$1,248.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted four to one that Royal Construction and Management, LLC shall pay a civil penalty of \$10,000.00 for violation of Act 150; \$5,000.00 for violation of Act 162 as amended for a total of \$15,000.00 to be reduced to \$7,500.00 if no further violations for 3 years to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

Code Ann. § 17-25-401, *et seq.*.

Bond, d/b/a Superior Heating/Cooling and Electrical Inc. shall pay a civil penalty of \$948.81 for violation of Act 150; \$948.81 for violation of Act 162 as amended for a total of \$1,897.62 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

within six months to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

Code Ann. § 17-25-401, *et seq.*
