FINDINGS OF FACT**

**ARKANSAS CONTRACTORS LICENSING BOARD**

**vs.**

**HARMAN & SON CONSTRUCTION, INC.**

**ORDER**

The Board voted unanimously that Harman & Son Construction, Inc. shall pay a civil penalty of \$1,226.00 for aiding and abetting unlicensed contractors and failure to cooperate with an investigation payable to the Board within twenty (20) days of receipt of this Order. The Board further voted to revoke the license of Harman & Son Construction, Inc. for this violation. Harman & Son Construction, Inc. shall refrain from aiding or abetting or using contractors in violation of the contractors licensing law.

**ORDER**

The Board voted three to one that Chamberlain Mechanical, Inc. shall pay a civil penalty of \$100.00 for providing false information to the Board payable within twenty (20) days of receipt of this Order.

**ORDER**

The Board voted unanimously that Open Aire, Inc. shall pay a civil penalty of \$24,000.00 for violation of Act 150; \$25,273.00 for violation of Act 162 as amended for a total of \$49,273.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

**JONATHON WALL**

**ORDER**

The Board voted unanimously that Jonathon Wall shall pay a civil penalty of \$530.00 for violation of Act 150; \$530.00 for violation of Act 162 as amended for a total of \$1,060.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

**REBECCA JERNIGAN, D/B/A JERNIGAN ENTERPRISES**

**ORDER**

The Board voted three to one that Rebecca Jernigan, d/b/a Jernigan Enterprises was not in violation of the Arkansas Contractors Licensing law on this project. Rebecca Jernigan, d/b/a Jernigan Enterprises shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
