**ARKANSAS CONTRACTORS LICENSING BOARD**

**CHAMPION BUILDERS, INC.**

**ORDER**

The Board voted unanimously that Champion Builders, Inc. shall pay a civil penalty of \$7,500.00 for aiding and abetting and using unlicensed subcontractors payable to the Board within five (5) days of receipt of this Order. This amount is suspended to \$5,000.00 if there are no further violations for 3 years. Champion Builders, Inc. shall refrain from aiding or abetting or using contractors in violation of the contractors licensing law.

The Board voted unanimously that Randy Hammett, d/b/a R-H Concrete Works shall pay a civil penalty of \$2,170.38 for violation of Act 150; \$3,617.30 for violation of Act 162 as amended for a total of \$5,787.68 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

Code Ann. § 17-25-401, *et seq.*.

The Board voted unanimously that Suburban Construction shall pay a civil penalty of \$2,045.49 for violation of Act 150; \$2,045.49 for violation of Act 162 as amended for a total of \$4,090.98 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.
