**ARKANSAS CONTRACTORS LICENSING BOARD**

**ORDER**

The Board voted unanimously that Compressor Technologies, Inc. shall pay a civil penalty of \$25,706.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

The Board voted unanimously that Mike Dunn, d/b/a Dunn Contracting shall pay a civil penalty of \$1,647.00 for violation of Act 150; \$1,647.00 for violation of Act 162 as amended for a total of \$3,294.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Cecil Richardson shall pay a civil penalty of \$2,055.00 for violation of Act 150; \$2,055.00 for violation of Act 162 as amended for a total of \$4,110.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

**RODNEY NEEDHAM, D/B/A BK CONSTRUCTION**

**ORDER**

The Board voted unanimously that Rodney Needham, d/b/a BK Construction shall pay a civil penalty of \$1,765.00 for violation of Act 150; \$1,765.00 for violation of Act 162 reduced by one-half if licensed within 120 days as amended for a total of \$3,530.00 to the Board to be reduced to \$1,765.00 if Rodney Needham, d/b/a BK Construction obtains a license within 120 days, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

162 but assessed no penalty as amended for a total of \$12,000.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
